



# KRUGERRAND: PRE-APPLICATION

## - DOMESTIC DEALER

### INSTRUCTIONS

In order to apply to become a Krugerrand dealer, a formal application process must be followed.

The basic criteria to trade in Krugerrands is listed below. A list is also provided of the information required upon formal application. Please ensure that you comply or qualify BEFORE requesting the formal application form.

*Please note that in order to submit a formal application form a fee of R5000 is required, accordingly proof of payment should accompany your application.*

The application process steps are:

1. The applicant should read this pre-application form and ensure they meet the relevant criteria / have the relevant information.
2. The applicant should sign this pre-application to trade form, and return it to [sourcing@gold.co.za](mailto:sourcing@gold.co.za) requesting a formal application to trade form.
3. The applicant should fill in the application to trade and return it, together with all required attachments, along with their proof of payment of R5000 to [sourcing@gold.co.za](mailto:sourcing@gold.co.za) and [debtors@gold.co.za](mailto:debtors@gold.co.za).
4. Rand Refinery will consider the application for completeness, and apply the relevant due diligence procedures.
5. The applicant will be invited for an interview (either in-person, web-based, or telephonic) with the relevant Rand Refinery personnel to assess the application to trade.
6. Rand Refinery will evaluate the application and determine whether the applicant is successful or not.
7. An applicant will be informed in writing of the success of their application to trade.

### BROAD CRITERIA AND INFORMATION

1. Price: Rand Refinery sells Krugerrands at the LBMA fix plus a premium.
2. Rand Refinery sells only to authorized dealers, not the general public. Our minimum order size is 10 units per size ordered for the 1oz Krugerrand. If you intend to order less than 10 units per size per order, and less than 120oz per year, we recommend you to contact our approved dealers, who are listed on our web-site.



- 3. You should be involved in the business of coin/investment dealing and have a demonstrable track record of sales of investment or collectible products.
- 4. If you are new to Krugerrand dealing, you will need to provide us with your business plan.

## POST ACCEPTANCE REPORTING

1. On an annual basis, the dealer will provide annual financial statements and tax clearance certificates.
2. On an annual basis, the dealer will provide proof that their FICA registration is up to date.
3. On a quarterly basis, or more frequently if needed, Rand Refinery may request information on the customer's sales portfolio. If requested, the dealer will provide a list of all sales made to companies, including the names of those companies.
4. The dealer will immediately report to FICA, and any other relevant authorities, any activity which it considers could be illegal (such as money laundering, defacing or melting down of coins).

## ACKNOWLEDGEMENT AND DECLARATION / DISCLAIMER

I/We (the Applicant) hereby declare and acknowledge that:

I/We am/are aware of and will abide by all local statutory requirements relating to compliance, anti-money laundering, terrorist financing and dealing in conflict minerals.

I/We am/are not involved or engaged either directly or indirectly with any form of illegal activities including but not limited to such as melting down of Krugerrands.

I/We hereby accept that our application to become a Krugerrand will be subject to the approval of Rand Refinery (Pty) Limited. In the event that our application is unsuccessful, Rand Refinery (Pty) Limited will inform the applicant of the reasons for the application not being successful.

I/We agree that Rand Refinery (Pty) Limited may subject the Application to External Investigation / Verification.

I/We agree to abide by the application process described above and that any complaints or queries will be directed to sourcing@gold.co.za.

I/We agree to the required Post Acceptance Reporting regime, and understand that failure to do so may result in that Rand Refinery (Pty) Limited suspending or closing the trading account.
